PRIVACY AND COOKIE POLICY

Last Updated: May 20, 2021

This Privacy and Cookie Policy (this "**Policy**") describes how Gold Coin Studios ("**Gold Coin Studios**," "**we**," "**us**," "**our**") collects, uses and shares information about you. This Policy covers any personal information we obtain when you access www.goldcoinstudios.com (the "**Site**"). We may change this Policy from time to time. If we make changes, we will notify you by revising the date at the top of this Policy, and in some cases, we may provide you with additional notice (such as adding a statement to the homepages of our websites or sending you an email notification). We encourage you to review this Policy whenever you interact with us to stay informed about our information practices and the ways you can help protect your privacy.

This Policy also governs the use of personal information we obtain from you from any third party site or application where we post content or invite your feedback or participation, including, but not limited to, Twitter, Facebook, Instagram, YouTube, Pinterest, and Google+ ("**Third-Party Sites**"). Gold Coin Studios cannot control the privacy policies or practices of Third-Party Sites or of companies Gold Coin Studios does not own or control, and cannot control the actions of people Gold Coin Studios does not employ or manage. You should always check the privacy policies of Third-Party Sites and your privacy settings.

By continuing to use the Site, you are consenting to the practices described in this Policy.

PERSONAL INFORMATION WE COLLECT. We may collect or may have collected the following categories of information about you. In some cases, the information we collect may fall within more than one category.

- **Contact information and personal identifiers**, such as your name, address, email address, telephone number, and social media handle.
- **Device identifiers**, such as information about your device like your IP address, or other online identifiers.
- **Demographic information**, such as your age when you first access the Site.
- **Identity verification information**, in order to verify you when you call customer support or make other requests.
- **Online or network activity information**, such as information regarding your interaction with the Site.
- **Audio information**, such as recordings of your voice when you call our customer support.
- **User Content**, such as your communications with us and any other content you provide (including photographs, videos, reviews, articles, survey responses, and comments).

- **Inferences** drawn from or created based on any of the information identified above.

HOW WE COLLECT YOUR PERSONAL INFORMATION. We may collect or may have collected personal information about you from various sources. The categories of sources from which we may collect personal information are:

- **Directly from you**, such as when you contact us with a question or complaint.
- **Cookies and automatic collection methods.** When you visit the Site and when you open or click on emails we send you, we (and third parties we work with) may automatically collect information from your browser or device using technologies such as cookies, web beacons, pixel tags, and similar technologies. Cookies are small text files that websites send to your computer or other Internet-connected device to uniquely identify your browser or to store information or settings in your browser. Web beacons or pixel tags are small images which are embedded into the Site or emails that provide us with information about your browser or device, or whether you open or click on the emails we send you. These technologies enable us, or the third parties who place such technologies, to collect information such as device identifiers and online or other network activity information.
- **Through other technologies**, such as call recording technology when you speak to customer support.
- **From our business partners and service providers**, such as demographic companies, analytics providers, advertising companies and networks, third-party retailers, and other third parties that we choose to collaborate or work with.
- **From social media platforms and networks**, such as Facebook, Twitter, Pinterest, and Instagram. For example, we may obtain your information from a social media platform or network if you interact with us on social media or choose to log-in to the Site using your social media credentials.
- **From our affiliates** that you have interacted with.

HOW WE USE YOUR PERSONAL INFORMATION. We may use or may have used the information we have about you:

- To **provide content** or games of interest to you.
- To **communicate with you**, including to respond to your inquiries or complaints.
- For **marketing and advertising**, such as to send you marketing and advertising materials via postal mail or email, and to show you advertisements for games tailored to your interests on social media and other websites.
- For **analytics purposes**, such as to understand how you use the Site and to evaluate and improve the Site.

- For **legal and security purposes**, such as to detect, prevent, and prosecute harmful, fraudulent, or illegal activity, loss prevention, identify and repair bugs on the Site, and to comply with applicable legal requirements, relevant industry standards and our policies.

HOW WE SHARE YOUR PERSONAL INFORMATION. In general, we do not share personal information about you with third parties for such third-parties' own marketing or advertising purposes. We do share personal information with third parties for other purposes. For example, we share personal information with:

- Gold Coin Studios' **affiliates**, parents, and subsidiaries;
- **Service providers** that provide products or services to us, that help us market or advertise to you. Even with this access to personal information necessary to perform these functions, those third parties are not authorized by Gold Coin Studios to disclose your information for any other purposes. If, however, you become a direct customer with such third party (e.g., by subscribing to a mailing list of such third party or opening an account directly with such third party), then the third party's privacy policy would apply to the collection of your personal information for that purpose and not this Policy;
- **Social media platforms** and networks such as Facebook, Twitter, Pinterest, and Instagram that offer functionalities, plugins, widgets, or tools in connection with the Site. If you choose to use these functionalities, plugins, widgets, or tools, certain information may be shared with or collected by those social media companies—for more information about what information is shared or collected, and how it is used, see the applicable social media company's privacy policy;
- Parties to **business transactions** such as those we deal with in mergers, acquisitions, joint ventures, sales of assets, reorganizations, divestitures, dissolutions, bankruptcies, liquidations, or other types of business transactions. In these types of transactions, personal information may be shared, sold, or transferred, and it may be used subsequently by a third party; and
- Additional third parties such as **law enforcement**, government entities, courts, or other third parties as required or allowed by applicable law, or otherwise to help prevent harm or fraud to us, you, our customers, or other third parties.

CHILDREN. The Site is not intended for or directed to children under the age of thirteen and we do not knowingly collect personal information from children under the age of thirteen on the Site. If we become aware that a child under the age of thirteen has provided us with personal information, we will delete the information from our records.

PRIVACY PRINCIPLES. We ensure that our organization treats personal data lawfully and correctly. To this end we fully endorse and adhere to the data protection principles set out in legislation. In particular, without your consent or first amending this Policy to reflect any change in our usage of personal data:

- we will not use your personal data for any purpose that is incompatible with this Policy;
- we will only collect sufficient personal data for the uses set out above;
- we will endeavor to keep your personal data up-to-date;
- we will not retain your personal data longer than necessary unless required to do so by law
- we will operate appropriate technical and organizational processes to protect your personal data against unauthorized or unlawful access or processing and against accidental loss or destruction. The detailed measures we take are described elsewhere in this Policy; and
- We will hold your personal data for as long as we are providing services to you and for no more than five years thereafter. We will endeavor to delete any personal data sooner where it is not necessary for us to hold this, but please be aware that we may hold personal data for longer if we are under a legal obligation to do so or where we have a reasonable belief that it is necessary to do so for business or legal reasons.

SECURITY MEASURES. We are committed to protecting the security of your personal information. We use a variety of security technologies and procedures to help protect your personal information from unauthorized access, use, or disclosure. For example, we store the personal data you provide on computer systems with limited access that are located in facilities to which access is limited. It is your responsibility to ensure the security of your password and not to reveal this information to others.

INTERNATIONAL TRANSFER OF YOUR PERSONAL DATA. We are a global business and some of our service providers (e.g., our cloud storage providers) are located in countries outside of the European Union (EU). As a result, it may be necessary for the personal information that we collect from you to be transferred to or accessed from outside the EU in order for us to provide our services. If we do this, we have procedures in place to ensure your data receives the necessary protections. Any transfer of your personal data will follow applicable laws and we will treat the information according to the principles set out in this Policy.

EU USER'S RIGHTS WITH RESPECT TO PERSONAL INFORMATION. Depending on your local law, you may have certain rights with respect to your personal data, including:

- a right of access to a copy of the information comprised in your personal data;
- a right to access your personal data in machine-readable format and to request that we transfer this to a third party data controller;
- a right to object to processing that is likely to cause or is causing damage or distress;
- a right to object to decisions being taken by automated means;
- a right in certain circumstances to have inaccurate personal data rectified, blocked, erased or destroyed

If you contact us in relation to your rights we will do our best to accommodate your request or objection. If you request a copy of personal data that we hold about you, we may require a form of identification to be able to process your request. If you have a complaint about how we handle your personal information or respond to your request, you may be able to complain to your data protection

authority. We asks that you kindly contact us first, so that we have an opportunity to resolve your complaint.

 - **Right to Access Your Information:** You have the right to request the following covering the 12 months preceding your request:
 - The specific pieces of personal information we have collected about you
 - The categories of personal information that we have collected about you
 - The categories of sources from which we collected the personal information
 - The purpose for collecting or selling the personal information
 - The categories of personal information that we have disclosed about you, the purpose for disclosing such personal information and the categories of third parties with whom we disclosed such personal information
 - The categories of personal information that we have sold about you, as well as the categories of third parties to whom we sold such personal information
- **Right to Opt-Out of Sale:** We do not sell personal information in exchange for any monetary or other valuable consideration.
- **Right to Deletion:** You have the right to request that we delete any personal information about you that we have collected from you. Please note that there are exceptions where we do not have to fulfill a request to delete information, such as

when the deletion of information would create problems with the completion of a transaction or compliance with a legal obligation.

- **Right to Non-Discrimination:** We will not discriminate against you (e.g., through denying goods or services, or providing a different level or quality of goods or services) for exercising any of the rights afforded to you.
- **How to Exercise Your Rights:** To exercise your rights described above, please submit a verifiable consumer request to us by emailing us at admin@goldcoinstudios.com.
- **Verifiable Consumer Requests:** Only you, or a person registered with the California Secretary of State that you authorize to act on your behalf, may make a verifiable consumer request related to your personal information. You may only make a verifiable consumer request for access to your personal information twice within a 12-month period. The verifiable consumer request must: 1) Provide sufficient information that allows us to reasonably verify you are the person about whom we collected personal information or an authorized representative of that person; and 2) Describe your request with sufficient detail that allows us to properly understand, evaluate and respond to it. We cannot respond to your request to exercise your access and/or deletion rights if we cannot verify your identity or authority to make the request and confirm the personal information relates to you. Making a verifiable consumer request does not require you to create an account with us. However, we do consider requests made through your password-protected account sufficiently verified when the request relates to personal information associated with that specific account. We will only use personal information provided in a verifiable consumer request to verify the requestor's identity or authority to make the request.
- **Response Timing and Format:** We attempt to respond to a verifiable consumer request within 45 days after we receive it. If we require more time (up to 90 days), we will inform you of the reason and extension period in writing within 45 days after we receive your initial request. If you have an account with us, we will deliver our written response to that account. If you do not have an account with us, we will deliver our written response by mail or electronically, at your option. Any disclosures we provide will only cover the 12-month period prior to the date we receive the verifiable consumer request. The response we provide will also provide the reasons we cannot comply with a request, if applicable. For access requests, we will select a format to provide your personal information that is readily useable and should allow you to transmit the information from one entity to another entity without hindrance. We do not charge a fee to process or respond to your verifiable consumer request unless it is excessive, repetitive or manifestly unfounded. If we determine that the request warrants a fee, we will tell you why we made that decision and provide you with a cost estimate before completing your request.
- **Complaints.** In compliance with the CCPA, we commit to resolve complaints about your privacy and our collection or use of your personal information. California residents with inquiries or complaints regarding this Policy should contact us at admin@goldcoinstudios.com.

California's Shine the Light law. OPT-OUT FROM MAILINGS. From time to time, you may receive periodic mailings, e-mails or other communications from us with news or other information on games, or other offers from or on behalf of Gold Coin Studios. If at any time you wish to stop receiving communications from us please send us an email to admin@goldcoinstudios.com with the phrase "Privacy Opt-out " in the subject line, or write to us at the address provided below, and we will remove you from our mailing list. Alternatively, for e-mail communications, you may opt out of receiving such communications by following the unsubscribe instructions set forth at the bottom of most promotional e-mail messages from Gold Coin Studios.

WEB BROWSER COOKIES, WEB BEACONS, ALSO KNOWN AS "TRACKING PIXELS," AND OTHER TRACKING TECHNOLOGIES

Web Browser Cookies. A web browser cookie is a small text file that is sent by a website to your computer or mobile device where it is stored by your web browser. Web browser cookies may store information such as your IP address or other identifier, your browser type, and information about the content you view and interact with on the Site. By storing such information, web browser cookies can remember your preferences and settings for online services and analyze how you use online services. Below are some common terms that may help you to better understand cookies and how they work.

- **First- and third-party cookies:** Whether a cookie is 'first' or 'third' party refers to the domain placing the cookie. First-party cookies are those set by a website that is being visited by the user. An example would be the cookies placed by Company when you visit our website. Third-party cookies are cookies that are set by a domain other than that of the website being visited by the user. For example, if a user visits the Site and another entity sets a cookie through our website, this would be a third-party cookie.
- **Persistent cookies:** These cookies remain on a user's device for the period of time specified in the cookie. They are activated each time the user visits the website that created the particular cookie.
- **Session cookies:** These cookies allow website operators to link the actions of a user during a browser session. A session starts when a user opens the browser and ends when they close the browser. Session cookies are temporary, so all session cookies are deleted when the user closes the browser.

Web Beacons. Web beacons or "tracking pixels" (sometimes also referred to as tags) are small images which are embedded into our the Site that provide us with information about your browser or device, or whether you open or click on the emails we send you. This information is used to help our website and app publishers better analyze and improve their services to us.

We will collectively refer to all web browser cookies, web beacons, also known as “tracking pixels,” and other tracking technologies used on the Site as “**Cookies**” throughout the remainder of this Policy.

HOW DO WE USE COOKIES? The Site uses four categories of Cookies, which are explained in greater detail below.

- **“Strictly Necessary” or Essential Cookies:** These Cookies let you navigate through the Site and use essential features. Without these Cookies, services you request cannot be provided. These Cookies do not gather any information about you that could be used for marketing or for remembering what sites you have visited on the Internet.
- **Performance Cookies.** These Cookies collect information about how you use the Site (e.g., which pages you visit and if you experience any errors). These Cookies do not contain any information that could identify you and are only used to help us improve and maintain our the Site, understand the interests of our users and measure the effectiveness of our advertising. Our the Site use Google Analytics, a web analytics service provided by Google, Inc. (“**Google**”), to better assist Company in understanding how the Site are used. Google Analytics will place Cookies on your computer or device (identified above) that will generate information that we select about your use of the Site, including your computer or device’s IP address. That information will be transmitted to and stored by Google. The information will be used for the purpose of evaluating consumer use of the Site, compiling reports on activity on the Site for Gold Coin’s use and providing other services relating to activity on, and usage of, the Site. Google may also transfer this information to third parties where required to do so by law, or where such third parties process the information on Google’s behalf. The use of Cookies by Google Analytics is covered by Google’s Privacy Policy, available at <https://policies.google.com/privacy>.
- **Functionality Cookies.** These Cookies are used to provide services or remember settings that can improve your visit. Without these Cookies, our the Site cannot remember certain choices you have previously made or personalize your browsing experience by providing you with relevant information. These Cookies can also be used to recognize your device so that you do not have to provide the same information more than once. These Cookies allow the Site to remember choices you make (such as your user name, language or the region you are in) and provide enhanced, more personal features. For instance, these Cookies can be used to remember changes you have made to text size, fonts and other parts of the Site that you can customize.
- **Targeting/Advertising Cookies.** These Cookies may be set through our own the Site or by our third-party advertising partners in order to build a profile of your interests and show you relevant adverts on other sites. These Cookies may collect personal information about you, including web browser, IP address, device ID, name, location, email and phone number. Some of our third-party advertising partners may also share your browsing behavior with us. We, our third-party service providers and our third-party advertising partners, may also combine information obtained from these Cookies with personal information available from other sources, including data collected about you when you are using other websites and data collected about you offline, whether on our the Site or data that the third party maintains. To opt-out of targeted advertising, you may express your preferences at www.aboutads.info. Opting out of one or more ad networks only

means that those particular members no longer will deliver targeted content or ads to you. It does not mean you will no longer receive any targeted content or ads on the Site. If your browser is configured to reject Cookies when you visit the opt-out page at www.aboutads.info, and then you erase your Cookies, use a different computer or change Web browsers, your preference may no longer be active. Since all of these Cookies are managed by third parties, you should refer to the third parties' own website privacy notifications and policies for further information.

HOW CAN YOU CONTROL COOKIES?

Most web browsers are set to automatically accept Cookies but you can control and manage Cookies using your browser. Please note that removing or blocking Cookies can impact your experience on the Site and some functionality may no longer be available.

- **Browser Controls.** Most browsers allow you to change your cookie settings. Be aware that if you delete all Cookies then any preferences you have set will be lost, including the ability to opt-out from Cookies as this function itself requires placement of an opt out cookie on your device. These settings are usually found in the 'Options' or 'Preferences' menu of your browser.
- **Do Not Track (DNT).** This is a feature used by some browsers to send a signal to websites to indicate that the browser should not be tracked, which will cause Cookies used for purposes such as analytics and advertising to be disabled. As there are presently no current industry-wide uniform agreed and accepted standards on how DNT requests should be managed, currently we will not respond to any DNT signals.
